Bigland became Head of U.S. Sales in June 2011, where he is responsible for the Company's U.S. Sales Strategy, Dealer Relations, Order Facilitation, Incentives and Field Operations. Most recently, in May 2016, he was named Global Head of Alfa Romeo and Maserati.

In addition, Bigland is a member of the FCA Group Executive Council (GEC), a position he was named to in 2011. The GEC is the highest management-level decision making body within the FCA organization and is led by the FCA CEO.

Prior to his current roles, Bigland was Head of Alfa Romeo for North America and President and CEO of Ram Truck. He also served as President of Freightliner Custom Chassis Corporation, a South Carolina - based company.
